The strength of the Board of Trustees shall not be less than three and not more than 5 at any time.

The Board of Trustees shall have the power to appoint new or additional Trustee(s) within the prescribed limit and to fill vacancies in the office of Trustees by majority vote of 2/3rd of the total strength of the Trustees.

Any Trustee who acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or is otherwise unfit to continue as Trustee shall be liable to be discharged from its office by a resolution passed by at least 3/4th majority of the total Trustees for the time being except the Trustee proposed to be removed from the office, after affording him a proper and reasonable opportunity.

A trustee may submit resignation from the Board of Trustees, if he so desires or feels incapacitated or incapable of performing his duties or due to any reason whatsoever, and the same may be accepted by The Board of trustees.

It shall be lawful for the Trustees to get themselves reimbursed with the expenses incurred for the maintenance and the other expenditures for the fulfillment of the aims and objectives of the trust.
